The undersigned hereby releases and waives any claims that the undersigned may now or hereafter have against anyone associated with sportdogtrainingcenter.ca, Black Ridge, dog training activity sponsor(s), trainers, their representatives or agents, or their assigns from and against all liabilities, losses, damages, cost, or expenses of whatever kind or nature, including medical, veterinary and attorney's fees, which the undersigned may incur as a result of any activity undertaken at any facility or event run by, or managed by Black Ridge or in association with sportdogtrainingcenter.ca, without limitation, personal injury and damages thereof including loss of income, earnings, bodily injury, pain and suffering, emotional or mental distress, any and all medical expenses, and any and all veterinary and boarding expenses.

The undersign realizes and hereby acknowledges that any persons associated with Black Ridge or sportdogtrainingcenter.ca, their agents, instructors, and trainers can accept no responsibility whatsoever for the conduct and action of another person or their dogs, who may be participating in any event including but not limited to classes, event, or for other factors beyond their control. Accordingly as a condition of participation of the undersigned, their dog, and any other person with whom the undersign is associated with.

The undersign fully accepts responsibility for the conduct of their dog at all times and hereby agrees to release any persons associated with Black Ridge, or sportdogtrainingcenter.ca., trainers, and volunteers, for any and all claims, damages, injuries which they may suffer or incur, whether directly or indirectly, including liability for damages suffered by others, or their property, as a result of the conduct or actions of the undersigns or their dog.

ASSUMPTION OF RISK. The undersigned acknowledges and understands that the dog training activities undertaken involve potential risk of personal injury and injury to personal property including dogs which may result from participation in dog training and/or educational activities. Such injuries may be caused by other participants, the undersigned, owners, employees, volunteers of Black Ridge, and cause by facility conditions including, but not limited to, uneven terrain, natural or man-made conditions, which may be hazardous to the undersigned or create hazards to the undersigned's activities.

The undersigned acknowledges and understands that dog training activities are potentially dangerous and assumes all risk of injury and/or damage which may result from any reason whatsoever thereby.

BINDING EFFECT. The foregoing provisions shall be fully binding upon and shall be effective against the undersigned. Its heirs, successors, legal representatives or assigns and shall apply to the actions of the undersigned personally, their family guests, employees, volunteers, spectators, representatives or agents.
